

- Assemble flat mounting brackets (A) to conveyor bed assembly using four capscrews (B), and four flat washers (C).
- 3. Position attachment as shown, so mounting holes align with existing holes in conveyor bed frames.
- Assemble and tighten remaining four capscrews (B), and four flat washers (C) to secure conveyor extension attachment.
- Connect power and air supply and case sealer is ready for operation.




Figure 1 - Installation




Figure 2 - Parts Illustration
