Purpose of Attachment

When installed, the Caster Adapter Modification Kit enables using the standard 3M-Matic™ Caster Attachment Kit with the S867 Single Head Stand. This provides an easy and convenient means to move the stand and the S867 L-Clip Applicator from one location to another.




Figure 1—Caster Adapter Modification Kit

WARNING

- To reduce the risk associated with pinch entanglement, and pressurized air:
 - Turn off the main shut off valve or disconnect the compressed air hose before performing adjustments or maintenance on the machine.
- To reduce the risk associated with tipping hazards:
 - Mount the Caster Adapter Kit to enable mounting the casters to the outside of the S867 Single Head Stand legs. Refer to the installation instructions and illustrations in this document.
- To reduce the risk associated with muscle strain
 - Use appropriate rigging and material handling equipment when lifting or repositioning this equipment.

Installation Instructions

- If installed, remove the S867 L-Clip Tape
 Applicator from the S867 Single Head Stand. If it is not installed, continue with Step 2.
- 2. Lay the S867 Single Head Stand on its rear side on the floor or on a bench.
- 3. Mount one caster adapter plate to the bottom of each stand foot with the caster mounting hole on the outside of the frame as shown in Figure 1.
- 4. Place a 3/8" flat washer over a 3/8-16 screw in the caster adapter plate from the bottom.
- 5. Install and fasten one 3/8-16 flanged locking nut on the screw.
- 6. Repeat steps 3–5 for the other three stand feet.
- Mount a caster from the 3M-Matic[™] Caster Adapter Kit (PN 78-8069-3983-7) to each caster adapter plate according to the Instruction Sheet included with the Caster Adapter Kit.
- 8. Verify that all fasteners on the caster adapter plate and on the Caster Adapter Kit are secure.
- 9. Raise the S867 Single Head Stand upright on the casters.
- 10. Mount the S867 L-Clip Applicator as specified in the S867 Single Head Stand Instruction Sheet.
